ESI Super's flexible payment options for employers

4 ways for employers to make superannuation contributions to ESI Super		
1.	BPay	Use BPay to submit super contributions directly into a member account in ESI Super from banks, credit unions and building societies. Go to our website at esisuper.com.au . Click on 'Employers' then 'Payment options'. Please note: No paperwork is required for this option.
2.	Electronic Funds Transfer (EFT)*	Employers can automatically transfer super contributions to ESI Super's bank account. With this option employers are also required to submit a completed <i>Employer contribution remittance</i> Form or use 'Employer Online Access' to provide superannuation contributions information to the Fund.
3.	Cheques	All cheques sent to ESI Super must be accompanied by a completed <i>Employer contribution remittance</i> Form. Cheques should be made payable to ESI Super. We bank all cheques on the day of receipt if the associated remittance form is completed received by the Fund.

* ESI Super provides Employer Online Access facilities for participating employers to lodge their regular super contributions information to the Fund. To register for Employer Online Access please complete the Employer online registration Form which can be found in the back of the ESI Super Employer Guide.

- Employers can change their payment method at any time
- Our preferred payment method for participating employers is via EFT utilising 'Employer Online Access'. For non-participating employers with up to three employees our preferred payment method is via 'BPay'
